## **VIRGINIA GRAEME BAKER POOL & SPA SAFETY ACT (Became Law - December 2008)**

**You will NOT be able to open your pool this May if you  
are in NON-Compliance**

**1:00pm - 2:00pm: The Virginia Graeme Baker Pool and Spa Safety Act, instructed by: Mark Cukro - National Speaker, CAMT Instructor and Certified Pool Operator National Certification Instructor. This act is a NEW Federally mandated law that went into affect December 19, 2008 governed by: U.S. Consumer Product Safety Commission. It promotes the safe use of pools, spas and hot tubs by imposing federal requirements for suction entrapment avoidance. You will NOT be able to open your pool or hot tub in May if you are in non-compliance. There are very specific guidelines you need to follow and many conflicting reports circulating around regarding this law. Mark Cukro will explain this Act and help you understand what needs to be done for compliance before you open your pools and hot tubs in May.**
